GILL, John suddenly intended to depart this island, mariner.

St Michaels Parish, 28 Feb 1719/20, RB6/6, p. 107

My son William Gill at 21 - plantation in the Province of South Caroline in Berkly Co. butting land now or late of Thomas Smith, Job Howes, and Nathaniell Snow, and on Midway and Cooper Rivers now in the possession of George Legon Esq; estates in Bdos and Great Britain; daus Frances Gill, Anne Bellwain Gill, Mary Gill, and Jane Gill all at 16; my friend Henry Alleyne of St Michaels Parish - Xtr. signed John Gill

GILMAN, John, planter

St Josephs Parish, 13 Sep 1715, RB6/35, p. 448

Richard Yearwood of St Josephs Parish planter, one judgement to me before Hon. Richard Rarson Esq late Chief Judge of the Court of Common Pleas in St Andrews Parish; my chn Benjamin Gillman at 21, Mary Ann Gilman at 19, and Rachael Gilman at 18; my friends George Allen and Christopher Blake - Xtrs. signed John Gilman

GITTENS, Hannah, widow

St Philips Parish, 14 Jan 1720/21, RB6/6, p. 162

Son Nathaniell Gittens his chn, the chn of sons Joshua Gittens and Samuel Gittens decd, and the chn of dau Rebecca Bowman decd being all my gr chn; son Nathaniel and son in law John Bowman - Xtrs. signed Hannah (x) Gittens
